## ORDER

Government, in its order read as 2<sup>nd</sup> paper above, have sanctioned the payment of Social Security Pensions for the month of August 2016 /Advance for the month of September 2016 including arrears. It is reported that all District Co-operative Banks have completed the login with IKM sevana software.

In order to ensure the hassle free transfer of funds an amount of Rs.700 crore was sanctioned as per GO read as 3<sup>rd</sup> paper above to the District Co-operative Banks for the disbursement of Social Security Pensions through the District Co-operative Banks (DCB) / Primary Agricultural Credit Societies (PACS) and other Credit Cooperatives for the month of August 2016 /Advance for the month of September 2016 including arrears.
