**ORDER**

The Controlling Officer is authorized to draw the balance amount if any, required to meet the pension payment for June 2016, after adjusting the balance available (Total corpus minus interest portion) in the SB account opened for this purpose, from the Consolidated Fund of the State as detailed in the table given below and to deposit the same in A/c No.67234515304

maintained for this purpose with the SBT Main Branch, Thiruvananthapuram in the name of Director of Panchayats. The Controlling Officer shall move for additional authorization, if there is any shortage of funds in the concerned heads of accounts.
